**ARTICLES OF AMENDMENT
OF
SOCCER ASSOCIATION OF WESTERN HOWARD COUNTY, LTD.**

The Soccer Association of Western Howard County, Ltd., a Maryland non-stock corporation, having its principal office at 14601 MacClintock Drive, Glenwood, Howard County, Maryland, 20738, (which is hereinafter called the "**Corporation**"), hereby certifies to the State Department of Assessments and Taxation of Maryland that:

FIRST: Article Second of the Charter is hereby amended in its entirety to read as follows:

"Second: The name of the corporation (which hereinafter called the "**Corporation**") is: **THUNDER SOCCER CLUB OF HOWARD COUNTY, LTD.**"

SECOND: The Corporation is a non-stock corporation and has no authority to issue stock. Pursuant to the Corporation's Charter and Bylaws, the Trustees serving as such from time to time shall constitute the members of the Corporation.

THIRD: The foregoing amendment to the Charter of the Corporation has been advised by the Board of Trustees and approved by a majority of the members of the Corporation.
